SIGNED CONTRACT (Home Boarding)

Provanston has provided this home boarding contract so that you may further understand what is required of you and your dog before home boarding on our premises.

Provanston will only home board dogs, all other animals are excluded. You will be asked to read and sign this contract at the time of your dog's acceptance into our homeboarding program.

I further certify that my dog(s) have not harmed or shown any aggressive or threatening behaviour towards any person or any other dog.

I understand that all dogs wishing to home board must attend a pre-registration appointment to be assessed by us at Provanston and consequently deemed suitable for the multi-dog environment.

Provanston agrees to exercise due and reasonable care in the handling of the dogs, and in keeping the facility properly enclosed and sanitary. All dogs are cared for by Provanston without liability on Provanston's behalf for loss or damage from disease, theft, fire, death, escape, injury, or harm to persons, other dogs, or property by said dog(s), or for other unavoidable causes.

I HAVE READ AND UNDERSTAND THE FOLLOWING:

- 1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are in the care of Provanston and release Provanston of any liability arising from my dog's attendance and participation in homeboarding.
- 2. Provanston is covered by public liability insurance with indemnity to the value of £1,000,000.
- 3. I recognise that there are inherent risks of illness or injury when animals are allowed to be in close contact with one another. Such risks include but are not limited to, problems resulting from rough play and kennel cough. Provanston will isolate dogs which are suspected of having a communicable disease and contact the owner.
- 4. I further understand and agree that in admitting my dog(s) to home board at Provanston, Provanston has relied on my representation that my

- dog(s) is/are in good health and have not harmed or shown aggressive or threatening behaviour towards any person or any other dog.
- 5. I understand that my dog(s) will be playing in open areas with other dog(s) and accept that when dogs play in groups, they will get dirty, and nicks and scratches may occur, as well as any other inherent risks that are involved. I hereby release Provanston of any liability in the event of these or any similar incidents. I further understand and agree that the Provanston staff and volunteers will not be liable for any problems which may arise due to such.
- 6. I further understand and agree that any problems which develop with my dog(s) will be treated as deemed necessary by Provanston staff and volunteers, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved if Provanston decides to obtain medical treatment.
- 7. I accept that if my dog causes any excessive damage to the facility that I will be responsible to pay for repairs.
- 8. I understand that if my dog is not neutered or spayed by 6 months of age, they will not be allowed to participate home board with other dogs.
- I further understand that if my dog shows any signs of aggression towards other dogs, that their acceptance to home board will be re-evaluated.. Provanston will isolate dogs which are aggressive towards dogs and/or staff and contact the owner.
- 10. Human-aggressive dogs, or dogs with fear issues, will not be allowed to stay at Provanston. Provanston will not accept dogs listed under the Dangerous Dogs Act 1991.
- 11. As a responsible pet owner, I promise to keep my dogs(s) current in vaccinations against Canine Distemper, Infectious Canine Hepatitis (Canine adenovirus), Leptospirosis (L. canicola and L. icterohaemorrhagicae), Canine Parvovirus and other relevant diseases including Kennel Cough plus parasite and worm treatment. The course of vaccination shall have been completed at least two weeks before the first date of boarding or in accordance with manufacturer instructions.

It is required by Provanston that you provide official updated records from a veterinarian before you are allowed to homeboard. Provanston is not responsible for informing of due dates on vaccines nor will Provanston provide vaccine records for any reason. Furthermore, a record that this proof has been supplied must be kept on-site throughout the period the dog attends and for 12 months after the dog last attends.

12: I agree to providing minimum one weeks notice if my dog is not able to attend to avoid having to still pay the charge for the booking. Provanston understands that there may be times (in emergencies) where the 48 hours notice is not possible and these will be assessed on a case by case merit.

FEES:

Payable in advance of homeboarding commencing. If payment has not been made 24 hours in advance we reserve the right to cancel your booking

£40 per night per dog (24 hrs) £270 (1 week) £520 (2 weeks)

EMERGENCY: In the event of an emergency, Provanston will first attempt to contact the owner, followed by an attempt to contact the emergency contact person listed. Provanston may also directly contact the partnership veterinarian (Jackson Vets), if the circumstances are deemed such that immediate treatment is necessary.

THE PERMISSIONS:

Fresh drinking water shall be available at regular intervals (unless advised otherwise by a veterinary surgeon).

The drinking vessel shall be cleansed daily and the water changed as necessary.

Provanston may also use treats to reinforce positive behaviour in your dog(s). Please indicate in your booking and consent form if you do not wish your dog to be fed any specific treats/foods.

A booking and consent form must be filled out prior to confirming any bookings and this must be answered honestly.
